**Loan Interest Rate & Fees**

Your **starting interest rate** will be between

**6.41%** and **15.00%**

After the starting rate is set, your rate will then vary with the market.

**Your Starting Interest Rate (upon approval)**

The interest rate you pay will be determined after you apply. It will be based upon your credit history and other factors. If approved, we will notify you of the rate you qualify for within the stated range.

**Your Interest Rate during the life of the loan**

**Your interest rate is variable.** This means that your actual rate varies with the market and could be lower or higher than the rate on this form. The variable rate is based on the 90-day Average Secured Overnight Financing Rate (SOFR) (as published by the Federal Reserve Bank of New York). For more information on this rate, see the Reference Notes.

Although the rate will vary after you are approved, **it will never exceed 15.00%** (the maximum allowable for this loan).

**Loan Cost Examples**

The total amount you will pay for this loan will vary depending upon when you start to repay it. These examples provide estimates based upon the three repayment options available to you while in school.

| <b>2. PAY ONLY THE INTEREST</b><br>Make interest payments but defer payments on the principal amount while the student is enrolled in school.<br><b>Loan Term:</b> starting <u>after</u> the deferment period | \$10,000.00  | 14.16%   | 66 months   | <b>\$20,822.29</b>   |

| <b>3. DEFER PAYMENTS</b><br>Make no payments while enrolled in school. Interest will be charged and added to your loan.<br><b>Loan Term:</b> starting <u>after</u> the deferment period                       | \$10,000.00  | 14.16%   | 66 months   | <b>\$23,794.78</b>   |

**About this example**

The repayment example assumes that you remain in school for 4 years and have a 6-month grace period before beginning repayment. It is based on the **highest starting rate currently charged** and associated fees.

## REFERENCE NOTES

### Variable Interest Rate

This loan has a variable interest rate that is based on the 90-day Average Secured Overnight Financing Rate (SOFR) (as published by the Federal Reserve Bank of New York). Your rate will be calculated each quarter by adding a margin between 2.00% and 10.75% to the 90-day Average SOFR. The rate will not increase more than once each quarter, but there is no limit on the amount that the rate could increase at one time. If the Interest Rate increases, your monthly payments may be higher.

### Eligibility Criteria

#### Borrower

In order to obtain this loan, you must become a member of Oregon Community Credit Union.  
Borrower must be age of majority in state of residence at the time you apply.

#### Cosigners

Cosigner must be age of majority in state of residence at the time you apply.  
Rates may be, but are not necessarily, higher without a cosigner.

### Borrower Benefits

Interest rate discount of 0.25% for borrowers who are enrolled in recurring ACH payments. This discount is only applied for payments received via the recurring ACH process.

### Bankruptcy Limitations

If you file for bankruptcy, you may still be required to pay back this loan.
