

OCCU “Roseburg Scan for a Can” Sweepstakes

OFFICIAL RULES

NO PURCHASE IS NECESSARY TO ENTER THIS SWEEPSTAKES. ODDS OF WINNING DEPEND ON THE NUMBER OF ENTRIES.

SPONSOR/ADMINISTRATOR: The “Roseburg Scan for a Can” Sweepstakes (the “Sweepstakes”) is sponsored and administered by Oregon Community Credit Union (“OCCU” or “the Credit Union”), Contest, P.O. Box 77002, Springfield, OR 97475-0146 (the “Sponsor”).

ELIGIBILITY: The Sweepstakes is open and offered only to legal residents of the 50 United States and the District of Columbia, who are 18 years of age or older, possess a valid driver’s license, and who are members of, or eligible for membership in, the Credit Union at the time of entry (“Eligible Entrants”). Employees of Sponsor, and its affiliates and subsidiaries, and their immediate family members (spouse, parent, sibling and their respective spouses, regardless of where they live) or persons living in the same households of such individuals, whether or not related, are not eligible to enter the Sweepstakes or win a prize. THE SWEEPSTAKES IS VOID EVERYWHERE OUTSIDE OF THE UNITED STATES AND WHERE PROHIBITED.

AGREEMENT TO OFFICIAL RULES: By participating in the Sweepstakes, Entrants (the “Entrants”) agree to abide by and be bound by these Official Rules and the decisions of the Sponsor, which are final and binding in all matters relating to the Sweepstakes. Winning the Grand Prize is contingent upon fulfilling all requirements set forth herein.

METHOD OF ENTRY: The Sweepstakes begins at 12:01 am, Monday, May 8th and ends at 11:59 pm, Friday, June 9th (“Sweepstakes Period”). Eligible Entrants may enter only during the Sweepstakes Period. Postcard entries must be POSTMARKED NO LATER THAN Friday, June 9th.

1. Automatic Entry. Eligible Entrants are automatically entered to win when they visit the Participating Dealership listed below and scan the QR code located at the designated Sweepstakes entry table or other designated entry location. Sponsor will donate [describe what will be donated and how the amount will be determined].

2. Postcard Entry. Eligible Entrants may enter by mailing a 3” x 5” note card with their name, address, and telephone number to: OCCU’s “Roseburg Scan for a Can” P.O. Box 77002 Springfield, OR 97475-0146.

3. Limited Number of Entries. Limit one (1) entry per household/per Participating Dealership for the entire Sweepstakes Period. Postcard entries must contain the name of the Participating Dealership for which the entry is being submitted. Multiple entries from any household will be void. All entries become of the property of Sponsor. “Household” means and includes all persons residing at the same address.

GENERAL CONDITIONS: If for any reason the operation or administration of this Sweepstakes is impaired or incapable of running as planned for any reason, including but not limited to (i) infection by computer virus, bugs, (ii) tampering, unauthorized intervention, (iii) fraud, (iv) technical failures, or (v) any other causes beyond the control of the Sponsor which corrupt or affect the administration, security, fairness, integrity or proper conduct of this Sweepstakes, the Sponsor reserves the right at its sole discretion, to disqualify any individual who tampers with the entry process, and/or to cancel, terminate, modify or suspend the Sweepstakes in whole or in part, at any time, without notice and award the Prize using all non-suspect eligible entries received as of, or after (if applicable) this cancellation, termination, modification or suspension date, or in any manner that is fair and equitable and best conforms to the spirit of these Official Rules. Sponsor reserves the right, at its sole discretion, to disqualify any individual deemed to be tampering or attempting to tamper with the entry process or the operation of the Sweepstakes or Sponsor's Website, or acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Failure by the Sponsor to enforce any provision of these Official Rules shall not constitute a waiver of that provision.

RELEASE AND LIMITATIONS OF LIABILITY: By participating in the Sweepstakes, Eligible Entrants agree to release and hold harmless the Sponsor and its respective, employees, officers, directors, subsidiaries, affiliates, distributors, all prize providers, sales representatives, advertising and promotional agencies (collectively, the "Released Parties") from and against any claim or cause of action arising out of participation in the Sweepstakes or receipt or use of any prize, including, but not limited to: (i) any technical errors that may prevent an Entrant from submitting an entry; (ii) unauthorized human intervention in the Sweepstakes; (iii) printing errors; (iv) errors in the administration of the Sweepstakes or the processing of entries; or (v) injury, death, or damage to persons or property which may be caused, directly or indirectly, in whole or in part, by Entrant's participation in the Sweepstakes or receipt of any prize. Released Parties assume no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, entries. Released Parties are not responsible for any problems or technical malfunction of any telephone network or telephone lines, computer on-line systems, servers, or providers, computer equipment, software, failure of any e-mail or entry to be received by Sponsor on account of technical problems, human error or traffic congestion on the Internet or at any Website, or any combination thereof, including any injury or damage to Entrant's or any other person's computer relating to or resulting from participation in this Sweepstakes or downloading any materials in this Sweepstakes. Entrant further agrees that in any cause of action, the Released Parties' liability will be limited to the cost of entering and participating in the Sweepstakes, and in no event shall the Released Parties be liable for attorney's fees. Entrant waives the right to claim any damages whatsoever, including, but not limited to, punitive, consequential, direct, or indirect damages.

DRAWING AND NOTIFICATION: The Grand Prize Winner will be selected in a random drawing as set forth below. The Grand Prize drawing will be conducted, by the Sponsor, on or about Monday, June 26. Odds of winning the Grand Prize will depend on the total

number of eligible entries received throughout the Sweepstakes Period. The Grand Prize Winners will be contacted by the Sponsor as further described below in "ADDITIONAL PRIZE CONSIDERATIONS."

GRAND PRIZE: There will be one (1) Grand Prize awarded following the conclusion of the Sweepstakes Period. No other prize or prizes will be awarded. One Grand Prize Winner will be selected by random drawing from entries submitted at or to the participating Roseburg dealerships: Roseburg Honda, Lithia Ford Roseburg, Lithia CJDR Roseburg. The Grand Prize Winner ("Prize Winner"), upon the Sponsor's confirmation of eligibility, will receive a Grand Prize of \$1,000.00 ("Prize") paid in the form of a check payable to the Grand Prize Winner or, at the Grand Prize Winner's option, by direct deposit to the Prize Winner's OCCU account. No substitution or transfer of prize(s) will be permitted. The Sponsor reserves the right at its sole discretion to substitute the prize with another prize of equal or greater value.

ADDITIONAL PRIZE CONDITIONS: By accepting the Prize, the Prize Winner agrees to release and hold harmless the Released Parties from and against any claim or cause of action arising out of participation in the Sweepstakes or receipt or use of the Prize. The potential Grand Prize Winner will be notified by postal mail, email or telephone and may be required to sign and return to the Sponsor an Affidavit of Eligibility and a Liability & Publicity Release in order to claim the Prize. Prize Winner is solely responsible for all local, state, and federal taxes associated with the prize. The value of the accepted prize may be taxable as income and an IRS Form 1099 will be filed in the name of the Winner for the value of the prize and the Winner is solely responsible for all matters relating to the prize after it is awarded. If a prize or prize notification is returned as unclaimed or undeliverable to the potential Grand Prize Winner, if the potential Grand Prize Winner cannot be reached within three (3) business days from the first notification attempt, or if the potential Grand Prize Winner fails to return any requested document(s) within the specified time period, or if the potential Winner is not in compliance with these Official Rules, then such person shall be disqualified and, at Sponsor's sole discretion, an alternate winner may be selected.

MISCELLANEOUS: By accepting the Grand Prize, where permitted by law, the Grand Prize Winner grants to the Released Parties and those acting pursuant to the authority of Sponsor and the Released Parties (which grant will be confirmed in writing upon Sponsor's request), the right to print, publish, broadcast and use worldwide IN ALL MEDIA without limitation at any time, the Winner's full name, portrait, picture, voice, likeness and biographical information for advertising, trade and promotional purposes without further payment or additional consideration, and without review, approval or notification. IN NO EVENT WILL RELEASED PARTIES BE RESPONSIBLE OR LIABLE FOR ANY DAMAGES OR LOSSES OF ANY KIND (INCLUDING WITHOUT LIMITATION, DIRECT, INDIRECT, INCIDENTAL, CONSEQUENTIAL, OR PUNITIVE DAMAGES) ARISING OUT OF PARTICIPATION IN THIS SWEEPSTAKES OR THE ACCEPTANCE, POSSESSION, USE, OR MISUSE OF, OR ANY HARM RESULTING FROM THE ACCEPTANCE, POSSESSION, USE OR MISUSE OF THE PRIZE. By participating, Entrants release and agree to hold harmless the Released Parties from

any and all liability for any injuries, death or losses or damages to persons or property and CLAIMS/ACTIONS BASED ON PUBLICITY RIGHTS, DEFAMATION, OR INVASION OF PRIVACY that may arise from participating in this Sweepstakes or its related activities or the acceptance, possession, use or misuse of, or any harm resulting from the acceptance, possession, use or misuse of the Prize.

USE OF DATA: All information submitted by Entrants will be treated according to Sponsor's privacy policy, available at <https://www.myoccu.org/sites/default/files/pdf/OCCU%20Privacy%20Policy%202021.05.pdf>. By participating in the Sweepstakes and providing any personal information, Entrants hereby agree to Sponsor's collection and usage of their personal information and acknowledge that they have read and accepted Sponsor's Privacy Policy.

Notice to individuals; removal from mailing list. Any individual (or other duly authorized person) may elect to exclude the name and address of that individual from all lists used by Sponsor to mail contests or Sweepstakes notices or solicitations. To elect to have an individual's name excluded from all such lists, submit a removal request in writing to: Oregon Community Credit Union, Contest Mailing Removal, P.O. Box 77002, Springfield, OR 97475-0146. This notification system may be used to prohibit mailing of all skill contests or sweepstakes by Sponsor to such individual.

DISPUTES: All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules or the rights and obligations of Entrants' and Sponsor in connection with the Sweepstakes shall be governed by and construed in accordance with the laws of the State of Oregon, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other state's or jurisdiction's laws. By participating in the Sweepstakes, Entrant agrees that: (i) any and all disputes, claims, and causes of action arising out of or in connection with the Sweepstakes, shall be resolved individually without resort to any form of class action; (ii) any judicial proceeding in which Sponsor is a party shall take place in Marion County Circuit Court in the State of Oregon; (iii) any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, but in no event will attorney fees be awarded or recoverable; (iv) under no circumstances will Entrant be permitted to obtain awards for, and Entrant hereby waives all rights to seek, punitive, incidental, exemplary, consequential, special damages, lost profits, other damages, and/or any rights to have damages multiplied or otherwise increased; and (v) Entrant's remedies are limited to a claim for money damages (if any) and he/she waives any right to seek injunctive or equitable relief. The invalidity or unenforceability of any provision of these Official Rules will not affect the validity or enforceability of any other provision. If any provision of the Official Rules is determined to be invalid or otherwise unenforceable, the other provisions will remain in effect and will be construed as if the invalid or unenforceable provision were not contained herein.
